Former Dillon Police Officer Arrested Following Criminal Investigation

A former Dillon Police Department officer has been arrested following a criminal investigation conducted by the Montana Division of Criminal Investigation (DCI) into alleged misconduct that began earlier this year.

According to a press release issued by Dillon Police Chief Joel Stewart, former Officer Louis Ochoa III was arrested on July 15, 2026, by the Beaverhead County Sheriff's Office without incident.

The investigation began on March 6, 2026, when the Dillon Police Department initiated an administrative investigation after receiving information regarding alleged policy violations.

During the course of that investigation, department officials identified information indicating potential criminal violations. The matter was then referred to the Montana Division of Criminal Investigation (DCI) to conduct an independent criminal investigation.

The department stated that both the administrative and criminal investigations were conducted in accordance with applicable laws, department policy, and due process requirements in order to preserve the integrity of each investigation.

As a result of the administrative investigation, Ochoa's employment with the Dillon Police Department was terminated on April 7, 2026.

Following DCI's investigation, Ochoa was arrested and booked into the Beaverhead County Detention Center on the following charges:

- Count I: Tampering with Witnesses and Informants, a felony, in violation of § 45-7-206, Montana Code Annotated.
- Count II: Official Misconduct, a misdemeanor, in violation of § 45-7-401, Montana Code Annotated.

In the release, Chief Stewart said the Dillon Police Department remains committed to maintaining the highest standards of professionalism, integrity, and accountability.

"When allegations of misconduct arise, they are investigated thoroughly and impartially, regardless of an employee's position or rank," Stewart said.

Because the case remains an active criminal investigation, the department said it is unable to comment further at this time.

As with all criminal cases, the charges are allegations, and Louis Ochoa III is presumed innocent unless and until proven guilty in a court of law.

**Meadow Creek Fire Grows to 172 Acres West of
Lima; Aircraft Grounded Due to Thunderstorms**

The Meadow Creek Fire, burning west of Lima, Montana, has grown significantly since it was first reported, increasing from an estimated 15 acres to 172 acres, according to the latest update from WildCAD.

The wildfire is located up Meadow Creek Road, west of Lima toward Nicholia Creek, and is burning on Bureau of Land Management (BLM)-administered land that is protected by the Beaverhead-Deerlodge National Forest.

Firefighters from the Beaverhead-Deerlodge National Forest initially responded after receiving a report of smoke in the area. Early reports estimated the fire at approximately 15 acres.

Officials say the fire has exhibited mostly creeping behavior, with occasional wind-driven runs fueled by gusty northwest winds.

Two engines and multiple firefighters responded to the incident and continue working to contain the fire.

Aerial firefighting resources have been unavailable due to numerous thunderstorms and dangerous lightning in the immediate area. Officials said the hazardous weather conditions forced aircraft to remain grounded, limiting suppression efforts from the air.

The cause of the fire has not yet been released, and no evacuations or structure threats have been reported at this time.

Southwestern Montana News will continue to provide updates as additional information becomes available.

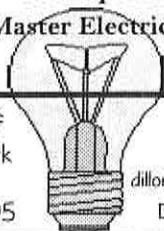

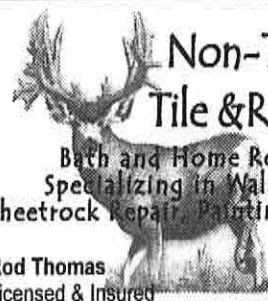

Attorney General Knudsen awards grants to support Montana Children's Advocacy Centers

Attorney General Austin Knudsen announced today the Montana Department of Justice awarded four Children's Advocacy Centers (CAC) with nearly \$150,000 in grant funds to help improve their care for child survivors of crime and abuse. The funding comes from a Johnson & Johnson settlement that resolved allegations the company manufactured, marketed, and knowingly sold baby powder tainted with carcinogenic asbestos.

CACs are facilities that provide care and support for children who have been abused or been a victim of a crime during the investigative process. Since 2024, the nine accredited CAC programs in the state and the Children's Alliance of Montana each received \$20,000 to support their work serving victims of crime and abuse in the first and second phases of the grant funding. In this third phase, accredited CACs are eligible to apply for and receive up to \$50,000 in grant funding annually through the program.

This week, Attorney General Knudsen was in Hamilton and awarded Emma's House Child Advocacy Center in Hamilton with \$37,874.69.

"Montana's child advocacy centers provide a supportive and safe environment for children during difficult times. That is why it is important that they have the funding they need to continue providing these critical services when Montanans need them the most," Attorney General Knudsen said.

The third phase of the grant program allows CACs to request funds for equipment and information technology; location, environment, and physical setting; and professional training expenses.

The programs that received funding from the third phase so far include:

- Emma's House Child Advocacy Center: \$37,874.69
- Fort Peck Tribes Red Bird Woman Center CAC: \$25,243.20
- Lewis and Clark County CAC of AWARE, Inc.: \$49,688.50
- First Step – Providence St. Patrick Hospital: \$29,700.80

"We are deeply grateful to Attorney General Knudsen for visiting Emma's House and seeing firsthand how the Children's Advocacy Center model serves children in the Bitterroot and across Montana. He understands what a CAC means for a case — stronger investigations and

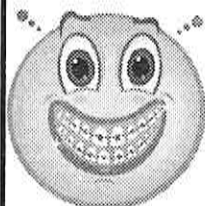

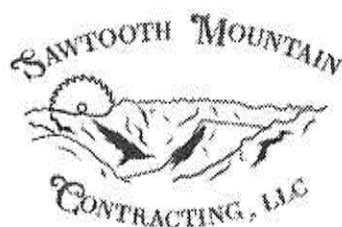

stronger prosecutions. More importantly, his thoughtful questions made clear he understands what it means for a child: reduced trauma, ongoing counseling, and a path toward healing. During the visit, Attorney General Knudsen presented Emma's House with a \$38,000 check from the Montana Department of Justice. These funds will support a critical technology upgrade to our forensic interviewing equipment, safety improvements to our building, and training for our MDT partners. This commitment translates directly into safety, justice, and healing for Montana kids. We're proud to have him as a partner in this work," Val Widmer, Executive Director, Emma's House Children's Advocacy Center said.

CACs provide a mentally and physically safe environment for abused children and their non-offending family members following a report of sexual abuse. The centers are a place for the multidisciplinary team (MDT) performing the investigation and caring for the child to convene, so the child does not have to go see each professional separately, which reduces the chance of additional trauma and the number of interviews or disclosures the child must give. It also increases the chance of successful prosecution by reducing potential evidence collection errors.

The Montana Department of Justice's Montana Child Sexual Abuse Response Teams (MCSART) currently has memorandums of understanding with the nine accredited CAC programs and the Children's Alliance of Montana.

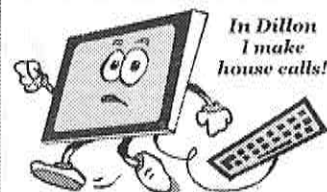

Surplus drawing license opportunities randomized Successful hunters to be contacted through email

Hunters who registered to be placed on the Surplus List can now check their status on MyFWP: myfwp.mt.gov/fwpExtPortal/myDrawResult_input.action. The list includes licenses left over from the drawing for Deer B and Elk B licenses.

FWP will contact hunters who are at the top of the list via email with instructions to finalize their purchase within a specified time.

Hunters must finalize the purchase of the license within the timeframe specified in the email; otherwise, the opportunity will be offered to the next hunter on the randomized list. FWP may offer opportunities that have not sold out through the Surplus License List to over-the-counter customers via OLS.

Residents may purchase a maximum of three deer licenses. This may be three Deer B licenses, or two Deer B and one General Deer license. Nonresidents may hold only one Deer B license or two if they hold a Nonresident Combination license.

Nonresidents who hold a Nonresident Native License, a Youth Combo License or a Nonresident College Student Combination License may purchase Deer B and Elk B licenses at half price.

Dillon Cubs Split Rescheduled Doubleheader With Bozeman Bucks in Dillon, Montana

The Dillon Cubs and Bozeman Bucks A split a rescheduled American Legion Baseball doubleheader Thursday afternoon in Dillon, Montana, after Wednesday evening's second game was postponed due to rain.

The Bucks rallied late to win the opener 9-5, while the Cubs answered with a dramatic 11-10 walk-off victory in the second game to earn a split before hosting the Butte Miners on Friday.

Bucks Rally Late to Take Game One, 9-5

Bozeman wasted little time getting on the scoreboard, taking a 2-0 lead in the first inning. Brock Fors drove in the game's first run with a sacrifice bunt before Hutch Hossner added an RBI single to left field.

The Cubs battled back in the third inning, tying the game at 2-2 on an RBI double by Sawyer Tackett and an RBI groundout by Andrew Bartlome.

Dillon seized control in the fourth inning, scoring three more runs to build a 5-2 advantage. Bartlome drove in a run with a fielder's choice, Trenton Moreni was hit by a pitch with the bases loaded, and Parker Mills drew a bases-loaded walk to cap the rally.

The lead held until the sixth inning when Bozeman's offense erupted.

The Bucks scored six runs on six hits in the top of the sixth to erase Dillon's lead and move in front 8-5. The biggest hit came off the bat of Isaac Ashcraft, whose two-run double highlighted the inning.

Bozeman added another run and held the Cubs scoreless the rest of the way to secure the 9-5 victory.

Kyle Dierolf earned the win in relief, allowing one run on three hits over three innings. Weston Schultz started for the Bucks, giving up five runs over four innings.

Aiden Ferguson was charged with the loss for Dillon after allowing eight runs, seven earned, over 5 1/3 innings while striking out three.

The Cubs collected seven hits in the opener, led by Ben Peacock and Sawyer Tackett, who each finished with two hits. Tackett, Moreni, Bartlome, and Parker Mills each drove in a run, while Dillon drew six walks.
